OUR CLASSES

Classes comprise a maximum of 15 students. Classes with fewer than 3 applicants will NOT be opened. In the case where there is a great demand for a particular course, the AFMM reserves the right to divide the students into 2 classes in order to obtain an equal number of students.

CANCELLATIONS AND REFUNDS

Should there be insufficient applicants to a particular course, the course will be cancelled and fees will be refunded in full. Should a student wish to cancel a registration a least a week before the course is due to start, fees will be refunded less a €15 administration fee. All requests for refunds must be made in writing. The AFMM regrets that there will be NO refunds for classes not attended or for the cancellation of a course by a student once the course has begun.

Course fees are non-transferable.

PLACEMENT TEST AND ADVICE

If you know some French and would like to check your level before applying for one of our courses, you may sit for a Placement Test. Tests will be carried out during the first two weeks of October. The placement test costs €15 and will be deducted when applying for a summer course, upon presentation of receipt.

MEMBERSHIP FEE

Students applying for any course may opt to become a Member by paying a membership fee of €15. Membership is valid for one year and allows its members a reduction on AFMM courses and activities. The Mediathèque annual membership fee is €10 and give its members access to AFMM physical library as well as to Culturethèque, the French online multi-media library of the Institut Français. Members of the same family applying for a course get a discount and only have to pay for the memberships once to benefit from our various benefits.
