OUR CLASSES

Classes comprise a maximum of 15 students. Classes with fewer than 6 applicants will NOT be opened. In the case where there is a great demand for a particular course, the AFMM reserves the right to divide the students into 2 classes in order to obtain an equal number of students.

CANCELLATIONS AND REFUNDS

Should there be insufficient applicants to a particular course, the course will be cancelled and fees will be refunded in full.

Should a student wish to cancel a registration a least a week before the course is due to start, fees will be refunded less a €15 administration fee. All requests for refunds must be made in writing. The AFMM regrets that there will be NO refunds for classes not attended or for the cancellation of a course by a student once the course has begun.

Course fees are non transferable.

PLACEMENT TEST AND ADVICE

Adults: If you know some French and would like to check your level before applying for one of our courses, you may sit for a Placement Test. Tests will be carried out during the first two weeks of July. The placement test costs €15 and will be deducted when applying for a summer course, upon presentation of receipt.

MEMBERSHIP FEE

Students applying for any course may opt to become a Member by paying a membership fee of €15, valid for a year. Membership allows its members a reduction on its courses and activities, as well as access to the library. Members of the same family applying for a summer course get a discount and only have to pay for the membership once to benefit from our various offers.

OUR FACILITIES

Members of the AFMM have access to our facilities. For those members joining our summer courses, we are offering the membership to the Médiathèque, free of charge. Membership of the Médiathèque will allow access to online reading material. Against a deposit of €15 members may also borrow books from our lending library.

BOOKINGS AND RESERVATIONS

Bookings are on a first come first served basis. We do not take bookings over the phone. Registration is final upon receipt of application form together with full payment.
